The following terms and conditions are agreed between Triple Cross Australian Shepherds, herein referred to as Seller and _____ herein referred to as the Buyer. The Seller agrees to sell and the Buyer agrees to buy based on the following conditions.

Purchase price of puppy \$_____. Less \$200.00 Deposit + shipping expenses if applicable \$_____. = balance due on puppy of \$_____.

A deposit in the amount of \$200.00 is required to hold puppy. The deposit must be received promptly (within 3 business days) in order to hold puppy. **Please use Express or Priority mail when sending payment.** The outstanding balance shall be paid to and received by the Seller before the Buyer shall obtain possession of the puppy. We accept credit cards, personal checks, or wire transfers to our bank. All funds must be in Seller's account before Buyer can take possession of puppy.

Both the Seller and the Buyer agree that the Seller will retain possession of the puppy until the puppy is 8 weeks old, unless other arrangements have been made in writing on this form. The Buyer must make arrangements with the Seller to obtain possession of the puppy by the time the puppy is 10 weeks old. Boarding fees will otherwise apply (\$7/day plus any medical expenses). Buyer forfeits deposit if the puppy is not paid for in full by the time the puppy is 8 weeks old. If puppy is already 8 weeks old or older when Buyer initially contacts Seller to purchase puppy, full payment should be made all at once. Any other arrangements must be agreed to by the Seller in advance. All puppies can be shipped by air. **The cost of shipping is normally \$275.00.** If the puppy is older than 12 wks., shipping may be more. If the puppy is shipped internationally, it may be more. All shipping costs are the Buyer's responsibility. Shipping costs include health certificate, vet exam, airfare, and crate. The Seller reserves the right to choose airline, time, and date but agrees to make every effort to accommodate the Buyer. Once the puppy leaves the possession of the Seller, the Seller is no longer responsible for the welfare of the puppy. If the Buyer wants the puppy shipped, Buyer will contact Seller for arrangements and shipping costs.

The deposit signifies that the Buyer intends to follow through with the purchase of the puppy from the Seller. In the event that the Buyer cannot follow through with the purchase of the puppy, the deposit is forfeited and NO refund will be given. If by tragic accident the puppy were to die or be determined to have a congenital defect that prevents the puppy from being a companion animal, before the Buyer takes possession of the puppy, a full refund of deposit will be given to the Buyer. If there is another puppy available that the Buyer wants to put the deposit towards, the deposit can be put towards that puppy.

In the event of litigation the venue shall be Hood County, Texas.
